MEDICAL DEFENCE FEES

South Staffs LMC has been alerted to a change in behaviour amongst Medical Defence societies which may have practical and financial implications for practices. Historically annual costs for particular types of doctors have been relatively uniform within any one doctor type e.g. GPs. However with rising litigation costs, most defence societies now risk assess GPs particularly those they know to be outliers in terms of complaints or claims against them. It seems that some GPs are now penalised for asking advice too many times.

In one recent case a GP partner working solely in hours has seen his annual defence society costs rise to £ 38K. This may be an unsupportable overhead that makes GPs leave the profession. Those GPs working out of hours have also faced rises in costs, possibly making it uneconomic to continue with this line of work.

Some practices pay the annual defence society subscriptions of the partners from practice funds (i.e. it is not a cost on any individual). Others pay the defence costs of salaried GPs they employ.

Practices may wish to consider whether the facts outlined above require a change to the way they handle the funding of annual defence society subscriptions.

This is a very significant issue for the profession over which the GPC is taking urgent action.

PMS CONTRACTS IN SOUTH STAFFORDSHIRE

The Area Team now known as NHSE North Midlands is currently responsible for PMS Contracts. The Government published a PMS Review framework in September 2014 which has been circulated to all practices. It has been proposed by the Medical Director, Ken Deacon, that there are 3 ways to deal with the move to equitable funding with GMS by removal of the PMS premium:

- 1. Return to GMS;
- 2. Tapering of PMS budgets over 7 years by not giving any uplifts until level with GMS funds. The calculations show this will provide less disruption in finances with advance planning;
- 3. Practice request for full PMS Review.

The final decision about the process to be offered to practices will be made in early May by the Joint Commissioning Board which includes the CCGs and AT. It is clear that any resources freed up from the PMS Review will be reinvested in General Practice services and will be used in the CCG of which the PMS practice is a member.

PHARMACY FLU VACCINATIONS TO UNDER 65 YEARS FOR 2015/16 FLU SEASON

Public Health has communicated their decision to offer flu vaccinations to under 65 years at Pharmacies for the 2015/16 flu season. The service offer is to those aged from 18 years to under 65s in clinical risk groups and pregnant women aged 18 years and over.

The LMC is disappointed that in spite of our strongly worded response they want flexibility before the support and maintenance of GP services. Practices will need to ensure they arrange their flu vaccine delivery dates as early as possible and target the under 65s first.

DO I HAVE TO ATTEND A FUNERAL PARLOUR OUTSIDE MY PRACTICE AREA TO COMPLETE A CREMATION FORM?

There is a legal requirement for a Cremation Certificate to be completed if a body is to be cremated. This does not equate to a legal requirement on an individual GP to sign it.

Reasonable funeral directors will arrange for the body to be viewed at a funeral parlour locally or alternatively pay the GP's requested fee to include time and travel costs.

The GPC recently met representatives of the funeral industry and agreed it is *never* acceptable to undertake an examination other than in appropriate premises.

Undertakers can arrange with local colleagues to provide a suitable venue.

The industry fully understands that it is its responsibility, on behalf of the family, to arrange the examinations and forms.

They also said its members would be willing to attend outside office hours if needed.
