#### PRESCRIPTIONS USING BOTH GENERIC AND BRAND NAMES

The Prescription Pricing Authority (PPA) treats prescriptions that include both the generic name and the brand name as prescriptions for the branded product. Up until now, if the branded product is a blacklisted item the PPA has made an exception and allowed the prescription and made payment based on the generic price.

The PPA has now decided to update their pricing procedures and no longer make an exception in this situation so that a prescription written using both the generic name and a blacklisted brand name will be interpreted as an order for a blacklisted product and they will disallow the prescription.

Some GP computer systems may be set to order prescription using both names e.g. Co-proxamol (Distalgesic). From 1st December these prescriptions will be disallowed and we thought it appropriate to inform you so that you are aware of the change and make any adjustments necessary to prevent disallowed prescriptions being returned.

#### **NHS BODIES**

Please read the GPC guidance. If a practice opts to become a Health Service Body, contract disputes will have to be dealt with through the NHS dispute resolution regulations. There is no alternative. If a practice holds a private law contract i.e. does not elect to become a Health Service Body, it can choose to use either the NHS dispute procedure or use the Courts in relation to any particular dispute.

The LMC view is that it is up to individual practices to decide whether to become a Health Service Body.

#### DATA PROTECT CLAUSE 472 INDEMNITY CLAUSE 473/474

The Department of Health has confirmed deletion of these clauses from the draft Standard Contract.

#### **NEW GMS CONTRACT**

You should have received the two LMC letters on Enhanced Services and Provision of Services Outwith Essential GMS. We are forming a central LMC negotiating team and are committed to getting the best deal for services you wish to provide.

#### **CREMATION FORMS**

A recent circular from the Home Office informed medical referees "that they are recommended not to accept without further enquiry applications where doctors completing form C have not made enquires of a relevant third party (i.e. that one of questions 5-8 should be answered in the affirmative)".

It would aid completion of the form if the doctor filling in part 1 of the form could inform the doctor assigned to fill in part 2 of a relevant telephone number to allow confirmation in the affirmative of one of the questions 5-8.

Home Office advice is that if the GPs have not seen each other Form C should be completed to show that enquires have been "adequate".

#### **VIOLENT PATIENTS**

Please note that PCTs are legally required to have schemes in place by 1st February 2004. Advice for removal of violent patients is to inform the police first then the PCT. We should no longer be allocated violent patients from 1st April 2004.
